



How Do I Know if I Have a Problem with Gum Disease

Periodontal (gum) disease often develops silently, with no warning signs. That's why it's important to visit your dentist regularly. Your dentist can check your teeth and gums and take x-rays, if necessary, to diagnose possible problems.

It's important that you be aware of the "eight silent signs" that may be symptoms of periodontal disease:

- 1. Gums that bleed when you brush your teeth.
- 2. Red, swollen or tender gums.
- 3. Gums that have pulled away from your teeth.
- 4. Puss that appears between your teeth and gums when the gums are pressed.
- Teeth that are becoming loose or that are changing position.
- 6. Any change in the way your teeth fit together when you bite.
- 7. Any change in the way your partial dentures fit.






The "Mayflower Compact" was signed on 11 November 1620 onboard the *Mayflower* shortly after she came to anchor off Provincetown Harbor. The Pilgrims had obtained permission from English authorities to settle in Virginia, whose northern border at the time extended up to what is now New York. They had originally intended to settle near the mouth of the Hudson River, but due to dangerous shoals and a near—shipwreck on their attempt to head south, they decided instead to plant themselves outside the bounds of the Virginia Company. The Mayflower Compact was an attempt to establish a temporary, legally-binding form of self-government.

The original Compact has been lost, and perhaps fell victim to Revolutionary War looting. A copy of it is found in William Bradford's handwritten history, *Of Plymouth Plantation*, created about 1630.

The first words spoken to the Pilgrims by a native American, Squanto, were "Welcome, Englishmen!" Squanto was a Pawtuxet native who had lived in Europe for several years and had been trading with the English in Cape Cod Bay for many years before the Pilgrims arrived.

The Pilgrims, who were of the Puritan faith, came to the new World to build a better life for their children. They toiled and starved and died in that effort. They laid the foundations of democracy on our continent as they set up a democratic form of government away from the monarchy of "divine right," and created the first foothold for the natural rights of man.

Pilgrim parents, children and community came together to face

and overcome unforeseen hardship and personal tragedy. Their fragile community built schools, churches, and sustenance as they clawed their way to religious and personal freedom built upon community sacrifice and cooperation. Even then that powerful partnership created the original building blocks of America.

Happy Thanksgiving and let's give thanks for all we enjoy, with deep appreciation for the sacrifice of people and institutions we never knew, whose legacy lives on in better schools and better communities.

In ye name of God Amen· We whose names are vnderwriten, the loyall subjects of our dread soueraigne Lord King James by ye grace of God, of great Britaine, france, & Ireland king, defender of ye faith, &c Haueing vndertaken, for ye glorie of God, and aduancemente of ye christian faith and honour of our king & countrie, a voyage to plant ye first colonie in ye Northerne parts of Virginia· doe

by these presents solemnly & mutualy in ye presence of God, and one of another, couenant, & combine our selues togeather into a ciuill body politick; for <u>ye our</u> better ordering, & preseruation & fur therance of ye ends aforesaid; and by vertue hearof, to enacte, constitute, and frame <u>shuch</u> just & equall lawes, ordinances, Acts, constitutions, & offices, from time to time, as shall be thought most meete & conuenient for ye generall good of ye colonie: vnto

which we promise all due submission and obedience. In witnes wherof we have herevnder subscribed our names at Cap Codd ye $\cdot 11 \cdot$ of Nouember, in ye year of ye raigne of our soueraigne

Lord king James of England, france, & Ireland ye eighteenth and of Scotland ye fiftie fourth. Ano: Dom ·1620·|

IT'S THE LAW

Over the past several months I have found myself representing a number of clients with issues related to Trusts. One of the remarkable things about the law is how flexible it can be.

I have learned that many people who act as trustees, do so without knowing the basics about trusts. So I thought I would deal with some of the ABC's of trusts in the hope that if any readers may remember that in all things you need to return to basics.

The First area of discussion will be irrevocable trusts.

Irrevocable trusts may be created during a person's life. This is called an inter vivos trust. Or an irrevocable trust may be created under a Will. This is called a testamentary trust. But not all irrevocable trusts are really irrevocable! Here's the scoop.

An irrevocable trust may be amended or revoked. Under the Estate Powers and Trust Law if all the people who have a beneficial interest in trust property consent in writing, the maker of a trust (called a creator under the law) may revoke or amend a trust.

There are strict requirements relating to the form that

must be used to effect any amendment or revocation, so don't try this on your own.

Is that all there is? No, if real estate was transferred into the irrevocable trust the papers signed consenting to the amendments or revocation *AND* the papers effecting the amendments or revocation must all be recorded. Also if there are disabled or minor persons with a beneficial interest in the trust property, then it cannot be revoked or amended. *BUT* there are court decisions that have allowed a revocation or amendment *IF* it can be shown that the changes are favorable to the minor or disabled beneficiary.

The trustee may also have the right to amend an irrevocable trust. But here the creator of the trust must use clear language that does not limit the power of the trustee to invade trust property and allows the trustee to exercise discretion in a broad manner.

The key to success in all this is proper draftsmanship. If you do not identify the beneficial interests of the beneficiaries of the trust or you limit the power of the trustee this won't work. As always the devil is in the details.

As the loyal readers of this column know -- you need to hire competent counsel and seek and receive good advice. So be careful and ask questions! *There are a host of "ifs, ands & buts."*


